



## Barbara Van Brimmer Remembered

*Barb had been a charter member of OHSLA and remained active in the organization, serving as OHSLA President from 2000-2001. She was also instrumental in providing a repository for the OHSLA Archives at the OSU Medical Heritage Center and in establishing the OHSLA Scholarship.*

Last month I had a birthday and despite her illness Barb sent me a card in which she wrote, "When are you going to catch up to me?" She was referring to the fact that I am three years younger, but I wanted to interpret the card differently. The answer is that I could never catch up to all the accomplishments Barb has had in her

career. I deeply regret that her cancer progressed so quickly that I never got to have a conversation to remind her of all she had accomplished.

So today I thought I would have that conversation with you. Barb came to our library in 1985 and in her 18 years with us she held 7 different positions each with more responsibility drawing on different strengths and interests. Her talent and passion for librarianship led her successfully through each position and on to the next challenge.

Barb's accomplishments are so impressive that she was to be nominated for promotion to full professor in the upcoming year. I am saddened that she will not be able to receive the honor she so deserved. She leaves a professional legacy with ten journal articles, several books and book chapters, twenty-five presentations, and ten awards and grants. Barb leaves a legacy of service as chair of the Medical Library Association's History of Health Sciences Section and president of both the Ohio Health Sciences Library Association and Central Ohio Health Sciences Library Association. She served on 50 university committees and 30 other committees both local and national. Through her leadership in these organizations, Barb has touched many people's lives and developed many friends who I know are

here today.

In 1992, Barb shared her dream to document the heritage of medicine in Columbus and Franklin County. As the librarian in charge of our history collection, Barb was often asked to answer questions related to the development of medicine. As a library with limited resources, adding a new department was a daunting task; but Barb was not dissuaded. With her enthusiasm, passion and determination, she received a grant from the Columbus Medical Association and funding from University Hospitals to develop the Medical Heritage Center. As librarians, we do not often have the opportunity to leave a legacy, but Barb has given all of us in the library a much deeper appreciation for the role of history—as well as a reminder that we need to appreciate the historical developments that have led to the amazing progress we have witnessed in medicine.

OHSLA says farewell as two long-time members start new phases in their lives. Mary Sprague left her position at the OSU Prior Health Sciences Library in December to run a vacation cabin in the Hocking Hills — <http://www.marsh-hollow.com>— and to take care of her 34-acre retreat there. Mary has contributed a great deal to our organization over the years. She was Treasurer of the Ohio Health Information Organization (our former name) for two years from January 1992 to December 1993. She was Treasurer of OHSLA from 1993 to 1994. Beginning in July 1997, she served three consecutive years on the Executive Committee as OHSLA President Elect/Program Chair, President, and Past-President. Since 1998, Mary has done an excellent job as our discussion list coordinator.

Jo Yeoh will retire on June 30 after spending more than 30 years as the Library Director at Riverside Hospital. Jo started her career at Johns Hopkins in 1972. In 1973, she moved to Columbus and took the job at Riverside Hospital. Jo has made numerous contributions over the years, including organizing the first library consortium in Columbus for the purpose of searching MEDLINE. In the 1970s, medical

libraries could not search Medline independently; they had to form a group to do so. Jo saw a need and decided to fill it (something she has been doing extremely well for over thirty years). She also had the first consumer health library in Central Ohio. Jo has lent her leadership skills to numerous library organizations as an officer, committee member, and mentor. She was one of three Midwest Chapter members featured at the National Library of Medicine's web site during October 1998 in recognition of National Medical Librarians Month. Recently, Jo served OHSLA as our representative to the Ohio Council of Library and Information Services (OCLIS) and as a member of our communications committee. Jo plans an active retirement as a volunteer at Riverside Methodist Hospital and possibly at the art museum and the zoo. She also hopes to do some traveling.

Congratulations and best wishes to both Jo and Mary. We will miss you very much, and wish you both much success and happiness in your new endeavors. Keep in touch!♦

The librarians at the Prior Health Sciences Library, in their concern for Barb, were able to reflect on happier memories. One librarian recalled the day the search committee interviewed Barb for her position at the library. She said, "There was another librarian we interviewed at the time who had credentials similar to Barb's and who interviewed well and seemed a promising candidate. Our decision came down to Barb or this other person; what I recall is a strong consensus among those of us involved that, despite similar credentials on paper, there was 'just something about Barb.'" Another colleague sees Barb everywhere she looks in the library. She was in charge of the library renovation and the beautiful building we have today is a direct reflection of her talents.

As a library staff, we are an extended family; seeing each other through births and deaths, good times and bad. There have also been some shining moments; one is the development of the Medical Heritage Center.

At the library, we have pledged to honor Barb's work in continuing the development of the Medical Heritage Center and are working with her family to establish a scholarship in Barb's name to enable other librarians to attend training in medical history and preservation.

So you see, there is no way to "catch up" to Barb. She is irreplaceable and the hole that she leaves in our hearts and lives will always be there. I want to thank Rick and her family for letting me have this conversation with you. ♦

## Fall Meeting Summary By Sarah Murphy, President Elect/ Program Chair

Theresa Ross Embrey presented *PDAs and the Role of the Librarian* at the OHSLA Fall Meeting, held October 16, 2003 in the Berry Room of the Nutter Center at Wright State University. Embrey, a library consultant, provided a practical overview of PDA hardware, software, content, and potential library applications. A sharing session followed.

Seventeen of the 24 participants submitted evaluations. Over 70% of participants rated the meeting facilities very good or excellent. Approximately 70% of meeting participants also found the content of the program, the clarity of the presentation, the expertise of the presenter, and the format very good or excellent. Suggestions for improvement mainly included requests for better handouts.

Planning for the next fall meeting is already underway. We have reserved the Shishler Conference Center in Wooster, Ohio for Wednesday September 15, 2004.
